- The Voting App can be accessed at <https://voting.pjm.com/voting/pages/secure/>
 - All users must be on a roster or be listed as a designate for a meeting, and have Voting Read/Write access in Account Manager
 - For assistance with issues logging in, please contact voting_support@pjm.com
- Voters can log in and vote or change previously submitted votes, as long as the vote remains open

- The Welcome page will list all groups currently using the Voting Application
 - Upon logging in, you will be made the active voter for any company for which you are on the roster
 - Verify that information is correct and hit Continue
 - If there is a company for which you will not be voting (or would prefer to vote for at a later time), hit Continue and navigate to the Registration Details page to unregister for that company
