#### ORDER ESTABLISHING SETTLEMENT JUDGE PROCEDURES

(Issued June 5, 2023)

1. Between March 31, 2023, and May 31, 2023, 13 complaints were filed challenging PJM Interconnection, L.L.C.'s (PJM) assessment of penalties to capacity resources during Performance Assessment Intervals<sup>1</sup> triggered by PJM's invocation of emergency procedures during Winter Storm Elliott (Complaints). On April 14, 2023, PJM submitted a motion requesting that the Commission establish global settlement judge procedures

encompassing all of these complaint proceedings (Motion). As discussed below, we grant the Motion and establish settlement judge procedures.

### I. Complaints

2. Winter Storm Elliott struck the PJM region from December 23-25, 2022, causing severely cold weather.<sup>2</sup> PJM implemented emergency procedures, which triggered Performance Assessment Intervals, on December 23 and 24. In each of the above-captioned cases, complainants object to the assessment of penalties for shortfalls in their capacity resources' performance during these Performance Assessment Intervals. The complaints raise a host of issues including, for example, claims that PJM violated its Tariff and that PJM's Tariff may be unjust and unreasonable.

### II. PJM's Motion

- 3. PJM states that it requests the appointment of a settlement judge to actively engage, through publicly noticed settlement conferences, with PJM, the complainants, and any intervenors across all complaint proceedings in a concerted, good faith effort to seek consensual resolution of as many of the disputes as reasonably possible.<sup>3</sup>
- 4. PJM states that it plans to answer each complaint and demonstrate that it properly assessed penalties consistent with the PJM Tariff.<sup>4</sup> However, PJM also acknowledges that these disputes could take several years to resolve, considering the complaint, rehearing, and appeal processes.<sup>5</sup> PJM states that timely, consensual resolution of these disputes may help support the long-term health of the PJM resource adequacy construct.
- 5. PJM additionally notes that the Commission has granted motions for the appointment of settlement judges in other proceedings and that other complainants have similarly called for the use of settlement judge procedures or some other form of alternative dispute resolution.<sup>6</sup>

6. PJM states that a global settlement proceeding would best provide, to the extent possible, a consistent outcome across these complaints.<sup>7</sup> To that end, PJM asserts that it seeks a single overarching settlement process, led and coordinated by a Commission administrative law judge to cover all of the complaint proceedings as well as any similar complaints that are filed by the time the Commission acts on the Motion.<sup>8</sup> PJM further notes that it does not seek suspension of any of the complaint proceedings while the settlement judge procedures are in effect.<sup>9</sup>

### **III.** Notice and Responsive Pleadings

7. Notices of the Complaints were published in the *Federal Register*. Parties filing a motion to intervene in each docket are listed in Appendix A. A notice of PJM's motion was issued on April 18, 2023, providing that comments and answers to PJM's motion

were due April 24, 2023. Timely comments and answers were filed by Lee County Generating Station, LLC (Lee County), SunEnergy1, LLC (SunEnergy), ComEd Zone Generators, Coalition of PJM Capacity Resources (Coalition), Competitive Power Ventures Holdings, LP (CPV Holdings), Old Dominion Electric Cooperative (ODEC), Calpine Corporation (Calpine), PJM Power Providers Group (P3), East Kentucky Power Cooperative, Inc. (EKPC), and Indeck Niles, LLC (Indeck Niles). Timely protests were filed by Vistra Corp. (Vistra) and Constellation Energy Generation, LLC (Constellation). Monitoring Analytics, LLC, acting in its capacity as the Independent Market Monitor for PJM (Market Monitor), and Cordova Energy Company LLC (Cordova) filed out of time comments on April 28, 2023, and May 9, 2023, respectively. On May 9, 2023, PJM filed an answer.

- 8. Several commenters, including some of those who filed complaints, state that they support the establishment of immediate global settlement judge procedures. Many commenters contend that resolving these complex disputes through protracted litigation before the Commission and courts may negatively affect the PJM market for years and that it is more efficient to engage in settlement discussions now. Calpine agrees with PJM that good faith discussions aimed at prompt settlement will advance the long-term interests of the PJM market and the region it serves.
- 9. Indeck Niles and P3 also argue that the global settlement must permit both complainants and intervenors to participate fully and receive relief. SunEnergy and ComEd Zone Generators request that any global settlement procedure be flexible enough to allow individual complaints to be severable from any settlement. ComEd Zone Generators requests that the Commission direct the settlement judge to take into account the individual circumstances of each complaint. ComEd Zone Generators further request that the Commission clarify that the settlement judge will be empowered to oversee all aspects of settlement procedures, including overseeing informal settlement

discovery.<sup>17</sup> Finally, ComEd Zone Generators suggest that the Commission add "non-decisional" staff to assist the settlement judge.<sup>18</sup>

- 10. Several commenters state that they anticipate filing a similar complaint in the near future and request that their proceeding be added to any settlement procedures. Some commenters also note that the Commission should stay the obligation to pay the penalties, pending resolution of these proceedings.
- 11. The Market Monitor states that it does not oppose instituting global settlement judge proceedings that would start without delay.<sup>21</sup> The Market Monitor states that a just and reasonable resolution should be based on consistent principles and should apply to all similarly situated market participants. The Market Monitor further states that a "blackbox" settlement that lacks any explicit basis in principles and is not based on whether the outcome is just and reasonable should not be allowed to supplant the filed tariff rules.<sup>22</sup>
- 12. Vistra and Constellation argue that the Commission should first address the complaints on the merits. Vistra argues that the Commission should, instead of establishing settlement judge procedures, issue a merits determination for each complaint as expeditiously as possible.<sup>23</sup> Vistra stresses that, if the Commission does initiate settlement procedures, it should make clear that any settlement discussion must include generators who are entitled to bonus payments.<sup>24</sup>
- 13. Vistra and Constellation further contend that, if the Commission does initiate settlement judge procedures, it should first issue an interim order providing guidance and

setting forth a legal framework within which settlement procedures can take place. <sup>25</sup> Constellation states that the Commission does not regularly establish settlement judge procedures at such an early stage, without some sort of initial order. <sup>26</sup> Vistra and Constellation also argue that allowing parties to settle is unfair to generators that performed during Winter Storm Elliott and undermines the capacity performance construct by signaling that penalties will be negotiable. <sup>27</sup> They further contend that any settlement should treat all generators the same, regardless of whether they filed a complaint. <sup>28</sup>

14. In its answer, PJM states that it is well within the Commission's authority to grant the Motion and initiate settlement procedures.<sup>29</sup> PJM states that it agrees that any settlement should treat all similarly situated generators the same, regardless of whether they submitted a complaint.<sup>30</sup> PJM asserts that it stands by its operators' actions but nevertheless recognizes that settlement discussions may help to resolve a number of key issues and save resources of all involved, including Commission staff.<sup>31</sup>

### IV. Discussion

#### A. <u>Procedural Matters</u>

15. Pursuant to Rule 214 of the Commission's Rules of Practice and Procedure, 18 C.F.R. § 385.214 (2022), the notices of intervention and timely unopposed motions to intervene serve to make the entities that filed them parties to these proceedings.<sup>32</sup>

16. Rule 213(a)(2) of the Commission's Rules of Practice and Procedure, 18 C.F.R. § 385.213(a)(2) (2022), prohibits an answer to a protest unless otherwise ordered by the decisional authority. We accept PJM's answer because it has provided information that assisted us in our decision-making process.

#### **B.** Substantive Matters

- 17. We grant the Motion to establish global settlement judge procedures to seek resolution of all matters raised in the complaint proceedings. We find that a settlement judge may assist the parties in reaching a satisfactory resolution of the issues raised in these proceedings. Given PJM's interest in finding a resolution to the issues raised in these proceedings along with parties' general collective willingness to engage in settlement procedures we find that these procedures are a reasonable first step. The Commission has previously found that providing parties the opportunity to enter into a mutually acceptable settlement of highly contested and complex issues is superior to years of ongoing litigation which, as PJM notes, could be disruptive to the market. We therefore disagree with Vistra's argument that settlement may set a bad precedent and undermine the capacity performance construct.
- 18. The complainants raise a number of issues. For example, some complainants allege that PJM made errors in its load forecast. Other complainants assert that PJM was required, but failed to, curtail non-firm exports prior to entering into emergency procedures. Some complainants also argue that PJM assessed them penalties despite not being dispatched or scheduled by PJM. In its answers filed thus far, PJM has stated that its load forecast was reasonable and did not cause PJM to act in any way that was inconsistent with its Tariff. PJM has also argued that its Tariff provides it with authority to allow non-firm exports when PJM believes it could assist neighboring systems without jeopardizing PJM's reliability. PJM further contends that, to the extent a resource was penalized that was not scheduled, it was because of the seller's economic choices, (i.e., its operating parameter limitations), and it was thus still properly assessed penalties per the terms of the Tariff. We clarify that all issues raised in the complaint proceedings,

including but not limited to those noted above, may be included in settlement discussions. Having made this clarification, we disagree with protests arguing that the Commission should first issue a merits order providing at least some guidance or setting forth a legal framework.

- 19. Accordingly, we direct that a settlement judge be appointed in the above-captioned dockets, pursuant to Rule 603 of the Commission's Rules of Practice and Procedure.<sup>34</sup> If the parties desire, they may, by mutual agreement, request a specific judge as the settlement judge in the proceeding. The Chief Judge, however, may not be able to designate the requested settlement judge based on workload requirements which determine judges' availability.<sup>35</sup> The settlement judge shall report to the Chief Judge and the Commission within 30 days of the date of the appointment of the settlement judge, concerning the status of settlement discussions and, if the settlement discussions are ongoing, again within 60 days of the appointment of a settlement judge.
- 20. If, after a total of 60 days from the appointment of the settlement judge, the parties have not reached an agreement, the Chief Judge shall terminate the settlement procedures and refer the matter back to the Commission; however, if the settlement judge reports that the parties are significantly progressing towards settlement and that continued negotiations may be profitable, the Chief Judge may grant the parties an extension to continue settlement procedures for up to an additional 30 days.
- 21. We note that the Motion does not request that the Commission hold the complaint proceedings in abeyance, and we agree with PJM that answers to the complaints may help all parties evaluate their litigation positions and, in that respect, may help advance the settlement process. Accordingly, answers to the complaints remain due on the date noticed for each complaint. The Commission, however, will abstain from addressing the merits while settlement negotiations are ongoing.

#### The Commission orders:

(A) Pursuant to Rule 603 of the Commission's Rules of Practice and Procedure, 18 C.F.R. § 385.603 (2022), the Chief Judge is hereby directed to appoint a settlement judge in this proceeding within 10 days of the date of this order. Such settlement judge shall have all powers and duties enumerated in Rule 603 and shall convene a settlement

conference as soon as practicable after the Chief Judge designates the settlement judge. If parties decide to request a specific judge, they must make their request to the Chief Judge within five days of the date of this order.

- (B) The settlement judge shall file a report with the Commission and the Chief Judge on the status of the settlement discussion within 30 days of the appointment of the settlement judge, and, if the settlement discussions are ongoing, again within 60 days from the date of appointment of the settlement judge. If the Chief Judge grants any extensions, the settlement judge shall file a report at least every 30 days thereafter, informing the Commission and the Chief Judge of the participants' progress toward settlement.
- (C) If, after a total of 60 days from the appointment of the settlement judge, the parties have not reached an agreement, the Chief Judge shall terminate the settlement procedures and refer the matter back to the Commission; however, if the settlement judge reports that the parties are significantly progressing towards settlement and that continued negotiations may be profitable, the Chief Judge may grant the parties an extension to continue settlement procedures for up to an additional 30 days.
