**NOTICE THAT PJM INTERCONNECTION, L.L.C.

Pursuant to this Court’s orders dated June 18, 2020, and June 26, 2020, PJM Interconnection, L.L.C. (“PJM”) hereby respectfully notifies the Court that it may support one or more petitioners in these consolidated review proceedings on one or more issues. In addition, PJM may also support the respondent’s position on select issues.

PJM is a regional transmission organization that is established by the Federal Energy Regulatory Commission. PJM is a transmission provider and operates the PJM interchange energy market and forward capacity market. In addition, PJM coordinates the movement of wholesale electricity in all or parts of Delaware, Illinois, Indiana, Kentucky, Maryland, Michigan, New Jersey, North Carolina, Ohio, Pennsylvania, Tennessee, Virginia, West Virginia, and the District of

Columbia. Acting as a neutral and independent entity, PJM operates a competitive wholesale electricity market and manages the high-voltage electricity grid to ensure reliability for more than 65 million people. Given that PJM acts as a neutral and independent entity in administering the competitive wholesale electric market, PJM is uniquely positioned to provide the Court with a better understanding of the wholesale electric markets and stands ready to better inform this Court on the issues presented on appeal.
