Dear Secretary Bose:

PJM Interconnection, L.L.C. ("PJM") respectfully requests any waivers of the Commission's filing and notice requirements necessary to permit the Joint Stakeholder Proposal filed by PJM on July 2, 2020, in the above-captioned docket to become effective on January 1, 2021, as requested in the filing. <sup>1</sup> As previously noted, the January 1, 2021 effective date coincides with the start of the next Regional Transmission Expansion Plan ("RTEP") eighteen-month reliability planning cycle. PJM often includes such blanket waiver requests in its Federal Power Act, section 205 filings but neglected to do so here due to oversight. No party is harmed by the additional prior notice afforded by the advance submittal of the JSP Filing although the requested effective date is more than 120 days after the filing date (*c.f.* 18 C.F.R. §35.3).
